## FIRST AID

**If on Skin or Clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**If Swallowed:** Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by the poison control center or doctor. Have person sip a glass of water if able to swallow. Do not give anything by mouth to an unconscious person.

## MIXING INSTRUCTIONS

### SHAKE WELL OR RECIRCULATE BEFORE USE

1. Fill sprayer 1/3 to 1/2 full of water
  2. Add dry flowables or dispersible granules
  3. Add emulsifiable concentrates
  4. Continue to agitate until tank is 3/4 full
  5. Add AIRFORCE last to the agitating spray tank
- If excessive foaming develops, the addition of a defoaming agent is recommended with decreased agitation.

## RECOMMENDED RATES

GROUND: 3-6 pints / 100 gallons of water

AIR: 1-3 GPA of spray solution per acre: 4 fl oz AIRFORCE per acre

Over 3 GPA spray solution per acre: 6 fl oz AIRFORCE per acre

## STORAGE AND DISPOSAL

**Storage:** Store in original container. Keep containers tightly closed. Do not allow water or other chemicals to be introduced into contents of container. Do not contaminate water sources with equipment wash water, spray disposal wastes or by cleaning of equipment. Do not store near feed or food products.
